

The Diocese of Central Newfoundland Protocol regarding the implementation and Usage of the Government Vaccination Passport

- Our government has made it clear that Proof of Vaccination is required of all Churches by law.
- In spite of the ambiguity created by the Government's launch of the Vaccination passport, they have made it clear that the requirements mandated should the Vaccination protocol not be used, is NOT an optional pathway, but is only to be used in exceptional circumstances.
- Proof of Vaccination, either through the Government Passport Electronic application, Government issued paper, or cards will be required for all services of regular worship as of October 22
- IMPORTANT: At the time of this writing, usage of the Vaccination passport continues to require all restrictions in relation to masking, seating, social distancing and all gatherings. In addition, all existing Government restrictions around social gatherings, group meetings, food preparation, and meals remain in place.
- We affirm our love and commitment to unvaccinated individuals, and commit to doing all that we are permitted to ensure inclusion as members of our faith community.
- At the discretion of parish incumbents, in consultation with the bishop, services requiring pastoral needs may be conducted without use of the vaccine passport. These will include but are not limited to: Confirmations, Baptisms Weddings and Funerals.
- Clergy may, if a need is discerned hold services designated as being held under the government exception guideline.
- All clergy are to be vigilant in knowing and following the most current Government guidelines.
- Each parish will provide help upon request for people to obtain the vaccination passport, or any documentation needed.
- Any Parish or congregation that is not ready to implement the Vaccine Identification protocol by October 22, are to follow the government exemption rules currently in place if the Vaccination passport is not used.

Government Exemption Rules (From the Government Website) Faith-Based Organizations.

If faith-based organizations do not verify proof of vaccination for all attendees at faith-based gatherings, they will be subject to the following restrictions: Capacity is limited to 50 per cent; Everyone must wear a non-medical mask at all times (including the officiant and musicians); Congregational singing is not permitted; The names and contact information of all attendees must be recorded and retained for 14 days for contact tracing, and must be shared with public health officials if requested; Physical distancing must be maintained between individuals from different family groups; and, Entry must be restricted to only those who do not have COVID-19 symptoms and who are not required to self-isolate for any reason.
